Dear CHER,

As per my phone message yesterday regarding [your article](#), I'm providing you with additional information on COVID-19, which I began publishing on February 25th. The information is provided by Swiss sources that have a 68-year record of impeccable scientific accuracy.

City councilwoman, and mayoral candidate, Jamie Whelan, and others, began receiving this and subsequent information during the first week of March.

Following are some of the main bullet points from our documentation, all of which I will be glad to provide, and which show that we preceded all official announcements from the CDC and WHO, regarding information now accepted as facts.

From February 25th:

- **This is already a pandemic and must be treated as such**
- **Avoid airplanes, ships, mass transportation, crowds**
- **Stay at home to avoid exposing yourself to risk of infection**
- **Real number of infections and deaths much higher than reported**
- **Actual incubation period up to four weeks to 3 months**
- **Spread by asymptomatic people; through air, breath, clothing, etc.**
- **Breathing masks useless, virus penetrates because so small**
- **Full-body protective suit, breathing apparatus only real protection**
- **Hermetic quarantine required, must be longer than 2 weeks**
- **Asian races initially most susceptible but will spread to others**
- **Virus becomes more aggressive over time, claiming more lives**
- **Children mainly immune, main hidden spreaders of disease**
- **China, US, etc., suppressed truth for political and economic reasons**
- **The WHO culpable for not immediately proclaiming pandemic risk**

Of special interest should be the actual up to three-month incubation period and the - only much later confirmed - asymptomatic spreaders and airborne transmission of the disease, which all help to account for the rapid, widespread nature of the pandemic, and

where no travel, or other traceable, associated factors were present, nor sufficiently explain.

These factors speak to the need for a much longer quarantine period than two weeks. And for both confirmed and suspected carriers, the hermetically sealed quarantines, with fully equipped personnel, are essential for containing, controlling and stopping the spread of the disease, as the hospitals and medical workers themselves may otherwise inadvertently contribute to the transmitting it.

The information about inadequate masks was further explained, in early March, as pertaining to the commonly available surgical kind, with further significant details about the greater effectiveness of other kinds of masks available to the public.

You will find, as will also be published in our newest press release this coming week, that warnings, from the end of April, that infants will also contract the disease in the womb, were confirmed by the recent birth of the first child found to already be infected, in France.

We also preceded all official confirmation of the multi-organ infections, issues with blood clotting and thromboses, the (as yet not recognized) differences in immune systems, not only between men and women but also between races. Our sources also state that the virus never leaves the body and can produce a wide variety of subsequent symptoms and effects, some not initially associated with, or traceable to, the virus. Hence also the reported recovery failures after supposed cure, etc.

We are also on record, beginning in 1989 and 1995, with specifying the origin of the coronavirus disease as bioweapons laboratories in China, though interestingly enough our sources claim that the Chinese government itself was not culpable.

In March, I foretold the coming hampering of services, aberrant behaviors, social unrest, shortages of foods, etc., some of which are already upon us.

In May, we were provided with and published information stating that, officially, at the end of June, worldwide cases would be reported as approximately 10,000,000 and deaths totaling around 500,000, numbers which were subsequently officially announced. We also published information that the US and Brazil would have the largest numbers of cases, as was also subsequently confirmed.

Of special concern, as I published on June 2nd, while perhaps done with the best of intentions, the relocation of several dozen confirmed or suspected COVID-19 infected homeless people, from the shelter to unnamed and not medically secured motels and hotels - without any accountability to the public - constituted a great risk to the community from this extremely contagious, Ebola level disease. As we know, both county and Flagstaff numbers also continue to rise. And, as our sources have stated,

so-called herd immunity is a myth, as are all the conspiracy theories that are widely spread online.

As NYC Dr. Parik Pilly said, in his [Al Jazeera interview](#), "The virus loves crowds." So, the proper measures, such as the CDC and WHO recommended, *subsequent* to our February 25th call for self-isolation and quarantine, i.e. the lockdown, must be continued for some time, while cures and treatments are being developed. As I have personally written to gyms, restaurants, childcare facilities, etc., months ago, public facilities must remain closed. Had we adhered to these recommendations and protocols, we wouldn't now be facing even more drastic increases in infections and deaths.

Vacillating, ineffectual, disease-prolonging, politically and economically motivated, half-measures must yield to reason and to the firm understanding that this disease doesn't care about the economy, or our beliefs, politics, hopes, careers, etc. And, as I, bluntly, pointed out to Joe Galli, from the local chamber, dead people don't buy or sell things.

So far, *all* of the parties - openly copied here as well - have remained tight-lipped about this life-saving information, provided to them since March 5th, when there were *five* cases in the state. As you know, today there are almost... *140,000 cases and over 2,600 deaths*.

The next, even more virulent wave is coming later this year, or early 2021. Worldwide numbers may go into the many tens of millions, or even unimaginably higher.

The correct response is a long overdue, *open investigation* into the claims and supporting documentation we've published, since February 25th, described to you here...and a matter of record. All results of that investigation should be *immediately* made available to the public.

It's rather telling that wasn't done *long ago*, certainly to put the ever-growing numbers of concerned citizens at ease, in case this is some kind of wild, fear-inducing ploy...instead of the painfully accurate, true facts irresponsibly withheld from the public.

Silence is also an answer...but it is the wrong one.

Arizona Hospital Scandal as Warnings Ignored, Nurses Quit and COVID Cases Skyrocket

Only FIVE cases March 5th, when statewide warnings sent to government, medical authorities, media, how to control COVID-19 pandemic, hidden from public, now over 150,000 cases

Records show that emails were sent by Michael Horn, American publisher of FIGU, the Swiss non-profit publisher of scientific information, to Arizona state and local officials, as well as media, regarding the true facts about the dangers of the COVID-19 pandemic, with life-saving recommendations how to contain, control and stop the spread of the disease.

The information – subsequently corroborated and confirmed by the WHO and CDC - included the earliest published warnings identifying the disease as a pandemic, the need for self-isolation, avoiding all travel and public transportation, the role of airborne transmission, etc., was intended to prevent the kinds of devastation already hitting other states.

But Arizona officials, including Gov. Doug Ducey, hid the information from the public with the help of newspapers like the *Arizona Daily Sun*, *Tucson Sentinel*, *AZ Central*, etc., as well as medical officials at Arizona Health Services, the Flagstaff Medical Center and Congressman O'Halleran, catering instead to the various businesses and economic special interests that pushed to minimize the safety recommendations contained within the warnings.

Documents show that Flagstaff city councilperson, Adam Shimoni and councilperson/mayoral candidate, Jamie Whelan, repeatedly dodged all requests to call for an investigation of the cover-up, which included the transfer of dozens of confirmed and/or suspected patients from a homeless shelter to unnamed, medically unsupervised motels and hotels, possibly putting at risk tens of thousands of Flagstaff residents.

The Flagstaff Medical Center was also repeatedly and accurately warned in advance of the challenges that COVID-19 would pose to its patients and personnel. NAH president and CEO, Flo Spyrow, also ignored the Swiss information calling for hermetically sealed quarantines and hazmat level protective equipment and breathing apparatuses for all medical personnel, as the most effective way to contain, control and stop the spread of the disease.

So far, Flagstaff mayoral candidate, Paul Deasey, is the only politician in the state who has promised to address the issue and conditions at the local hospital, where 23 nurses have already quit, citing inadequate protective equipment, training and other necessary precautions.

When Horn began sending the COVID-19 warnings and recommendations from his Swiss sources statewide, there were only five cases in all of Arizona. The state is now rapidly approaching 155,000 cases and already over 3,000 deaths.
