## **Brain**

He also wants to know if you have or know other pathological evils or if you have simply defeated the diseases?

43. This, however, was only possible when our humanity and our scientists abandoned certain negating and negative attitudes and actions, etc. and began to think and act in new forms.

**Billy:**

So that means you cannot tell us how we can fight these nasty diseases?

**Semjase:**

44. With this you unfortunately speak the truth, because the Earth-human must acquire the necessary knowledge himself/herself in this regard, because they grow in themselves through it and will understand many things only through it and learn the right manner of acting.

45. But if we were to give them the knowledge, then we would be giving the Earth-humans a method in their hands, which they in turn would exploit destructively and devastatingly, because the knowledge about fighting these diseases holds too many powers and too much power in itself for us to be able to designate it responsibly.

46. It is still too early for the human being of the Earth to be able to possess this knowledge.

47. Only through the ongoing and advancing evolution will they be able to integrate themselves into this knowledge and its power and might, if they will apply it in the given measure and according to creational laws and recommendations, without exploiting it in negative form.

**Billy:**

It is a devilish pity, but I understand your point of view, even if many will say that this is barbaric and megalomaniacal of you.

**Semjase:**

48. Only Earth-human beings will do that who are not yet capable of thinking in good form and because they themselves live in a barbarity that they are not able to recognise.

49. Therefore, they will scold us barbarously and arrogantly, even though we are not so in any wise, and deeply regret that we are not allowed to provide help in these and certain other things.

50. We do not have the right to influence and advance a human evolution more than is possible according to all creational-natural laws and recommendations and according to the respective level of evolution of a life form.

**Billy:**

What about metal alloys and so forth, as well as crystals and precious stones that are supposed to catch or absorb certain radiations?

**Semjase:**

183. That has its rightness.

184. Special things of this kind have a certain effect.

185. But they achieve only partially successes and are not one hundred percent effective.

186. Fundamentally, however, they are valueful and can save a lot of hardship and suffering, whereby the fact must be seen, nonetheless, that related successes are as a rule only won through delusion and imagination.

187. There are however certain methods to let crystals and precious stones etc. become effective medicines.

... But now I would like to pick up one more thing that we once talked about before saying goodbye, namely about crystals and precious stones, which according to your interpretations can become very dangerous for humans if they are in their possession or are even worn.

**Semjase:**

...

87. All crystals, semi-crystals, gemstones and semi-precious stones as well as various minerals of earthly origin are recipients and transmitters of human emotional impulses and thought energies in larger masses or in high carat values.

88. Depending on their type, they store less or more of these energies, which are discharged onto their owners in a concentrated manner again and influence them to a great extent.

89. But now the earthly sphere is, due to negative human thought vibrations which surround the Earth like a vibrating mantle, in an energy state of highest negative forces.

90. These negative forces were created, and are further developed every second, by the tremendous negative thought energies of the earthly-human life-forms, which through their heresies and many negativities put the whole world under the spell of spoiling and dangerous radiations.

91. However, since crystals of all kinds as well as precious stones and various minerals etc. are very strong absorbers and recipients of such energies, it could not fail that they have been excessively charged in negative form by these negative human thought energies and have become dangerous bringers of distress and misery.

92. Depending on their species and characteristics, many of them became mediators of disease, infirmity and death, if they were large enough or powerful enough to be possessed by humans.

93. Especially crystals and gemstones of all kinds are very sensitive recipients and collectors of negative as well as positive human thought energies and negative and positive emotions.

94. They are therefore already severely affected at their actual growth sites before they are found by humans.

95. This is due to the very strong negative force that surrounds the Earth.

96. But if man now wants to have crystals and precious stones in his possession, to possess them as values, to use them as jewellery or as health bringer, then he must first free them from the dangerous radiation that occurs in vibrational form, for otherwise they are able to bring death and destruction upon him.

97. In addition, it is absolutely necessary that these crystals and gems etc. are large enough and of sufficient carat value and are subjected to a new neutralization at least every five years, because through the enormous negative thought energies of earthly humankind they recharge themselves after this time with the negative forces mentioned, within only a few hours.

98. The neutralization can be carried out by a pyramid, by running water or by a simple apparatus, which I will describe after my explanations.

99. If man does not subject his possessions of the kind mentioned to the necessary neutralization, if this is already known to him, then he should not be surprised if he is strongly persecuted by illnesses, misfortunes, misery and need, by infirmity, by misfortune and even by death and destruction.

111. If, however, a negative form of energy thousands of years old fires at them, as is the case on Earth, then they species in the negative.

How about pearls?

**Semjase:**

116. They have the same properties as gemstones, crystals, minerals, etc.

120. For neutralization or simple purification, it is not necessarily necessary to have a special apparatus that absorbs and neutralizes the above-mentioned energies.

121. This means that vibrations can also be 'deducted' from the crystals or gemstones etc. by other methods and converted into neutral forces.

122. The neutral forces are then 'absorbed' again by the crystals and gemstones etc. and form the balanced force for a certain duration.

123. This is the case with neutralisation.

124. In case of purification, only from time to time the degenerated forces of negative or positive form that have penetrated are absorbed, but they are simply released.

125. A recharging of the crystals or gemstones etc. is not necessary in this case, because they are able to generate their compensating forces themselves in their natural lawsuitability.

126. If I have mentioned that such crystals and gemstones etc. only have to be purified every 7 years, then this is only necessary if the person wearing them has degenerated very negatively, e.g. torturers who feel joy in the torture of other humans.

127. Crystals and precious stones, etc., which are in the possession of normally positive or negative human beings, which are not in any way disfiguring, must never be subjected to purification, provided of course that the stones, etc. are in a balanced and purified as well as originally neutral state and origin, because on your Earth only these possess the natural and great forces which are valuable and usable for man.

Every Earthling should be aware of the fact that the characteristics of the human being's character play just as important a role as his or her activities, because this is very important in order to be fit not only from top to toe, but also in terms of consciousness and the function of the brain. So overall, everything in this regard is important to prevent dementia, at least that's what I gather from what you were about to say, or am I mistaken?

**Quetzal:**

You are right and you think very quickly. That is actually what I wanted to say, because the human being himself/herself conjures up dementia, so I was told, if he/she does not keep himself/herself fit in every conceivable process, so physically and consciously, and so with healthy and powerful as well as logical, rational and sensible thoughts, creates the corresponding feelings. This means that the human being has to lead a lifestyle of all-time conscious activity, because depending on how he/she leads his/her life in a relaxed as well as serene manner in this respect, he avoids a dementia disease. Therefore, as far as possible, all stress and isolation in social interactions with other people and with the environment should be avoided. If an overall positive lifestyle and a healthy attitude towards life and contact with fellow human beings and nature as well as with the entire environment is cultivated, then dementia can be avoided to the greatest possible extent. However, to a large extent does not mean that other and health factors cannot play a certain role in developing dementia, but either way a consistently fulfilled social life, as well as a healthy, well-educated character ever plays a very important role in sparing the human being from dementia until old age, as was impressively explained to me.

## **Diet**

**Quetzal:**

71. It was very puzzling to me why the events around Semjase were able to come to light, so that I looked into Jacobus in detail and noticed a deficiency in him that made him act in the well-known irresponsible form.

72. The deficiency appears in his diet, because he feeds himself too one-sidedly with animal food products.

73. This has the consequence for him that his thinking is inhibited and he becomes sluggish, which also leads to the fact that arising evil arbitrary impulses in him can be registered by him, but not brought under control by him in decisive and valuable time.

74. Animal food products impregnate his brain acid masses and weaken his reactions of thought flexibility, which in other words is called inertia of reaction and inertia of thought.

75. He should therefore focus his food more on plant products such as vegetables and fruits, which would positively influence his mental inertia.

76. Margreth has a similar case, but the opposite is true, as I regret to say:



77. In a completely unreasonable manner she abstains from any animal food products, which has the consequence for her that her thought and reaction sequences are exceeded in the value of the positive, whereby negative effects arise.

78. Her thoughts and reactions become too free and exceed the measure of the good, whereby she is no longer capable of distinguishing the real from the unreal, because by exceeding the healthy measure she is deprived of the necessary criticism.

79. More inhibited and sluggish thought forms and reactions in this respect are an important requirement for her, which is why she should take animal food products, which would not only lead to better thinking production, but also to better health in her.

80. Unfortunately, many Earth-humans have very different and erroneous views about food intake, which have a damaging effect on them.

81. The erroneous view that a human life-form can fully and better develop without animal substances is just as wrong as the view that large amounts of animal substances would influence the physical constitution for the better.

82. It is true in this regard that when human life-forms completely omit food products from animal substances, just as great deficiency phenomena appear in many respects as also when too much of such substances are enjoyed.

83. The entire structure and preservation of the human life-form rests in floral and faunal food, at least as far as the physical realm is concerned.

84. But if, for example, fauna food products are not available for the human form of life, or if they are avoided on the basis of erroneous assumptions, or even if they are avoided on the basis of types of life attitudes, then the missing animal substances must absolutely be replaced by plant substances which are, however, completely equivalent to animal substances, etc.

85. This, however, is not yet possible on the Earth, since these nutrients have remained almost undiscovered, and the few that are already known are avoided for incomprehensible reasons of disgust.

**Billy:**

... My next question is about the gene, which makes up the hereditary factor. Are you allowed to tell me something about it?

**Semjase:**

50. It is the carrier of hereditary properties in the colour-bodies.

**Billy:**

That is clear to me, but how does a gene originate – and are the chromosomes equal in all life-forms?

**Semjase:**

51. They are not, as far as the second question is concerned.

52. Depending on the kind of being, they are different, and they also vary in their number.

53. Human life-forms, however, normally have the same number of chromosome pairs.

**Billy:**

Do these colour bodies then have any influence on the age limit of the life-form? Or is the age a genetically determined factor?

**Semjase:**

54. Certainly, it is a result of the genes.

55. The genes control the cell functions via the brain and the spirit, and they direct life, regeneration and decay of the cells.

**Billy:**

Thanks, that's sufficient already. What functions do the chromosomes themselves have?

**Semjase:**

56. They determine type, form and gender of the life-form.

57. They are also the fundamental carriers of the genes, which exert their factorial influences on the chromosomes and, depending on the factor present, cause them to switch to normal or false circuits and can also cause mutations.

**Billy:**

Does mongolism also fall under such a mutation?

**Semjase:**

58. In this context only partially, because this is fundamentally based on a damage of germs due to numerous possibilities, which in many cases is able to generate a supernumerary chromosome.

**Billy:**

Unfortunately, I do not understand enough of this, but the answer is sufficient for me. However, what do these chromosomes consist of?

**Semjase:**

59. Mainly of proteins and nucleic acids.

**Billy:**

Good, but now, what about heredity?

**Semjase:**

...

61. Each gene results in the inheritance of once existing characteristics.

62. Each individual attribute contains the attributes of both determinative factors, namely the negative and the positive, the male and the female.

63. However, due to various possible influences, "faulty circuits" or "faulty breeds" can result, from which mutated life-forms can develop.

64. It can also happen that a dominant gene overshadows a recessive gene, whereby this gene cannot reach the development.

65. Nevertheless, both genes can then be passed on.

66. Of course, genes are also able to change in the course of time because, like everything else in the universe, they too are subject to an evolutionary or degenerative process.

**Billy:**

I understand, even if this is not exactly a distinct field of knowledge of mine. But what about the inheritance of knowledge or simply the intelligence?

**Semjase:**

67. This is in no way related to the genes, because **intelligence is the result of the evolution of the consciousness.**

68. However, spiritual and consciousness-based thinking and its resulting factors such as knowledge, essence of wisdom and intelligence are pure factors of the consciousness, which can therefore express themselves consciousness-based and organically – in the brain, which consists of acid substances.

69. These acids form the carriers of consciousness-based essence of wisdom and intelligence in a solid form, while the spirit, however, fundamentally contains within itself the same knowledge as a fine-fluidal factor.

70. Even as a coarse-substantial life-form, everything is determined by two factors, so therefore the purely spiritual or fine-fluidal life-form as well as the coarse-substantial form must be present.

71. In this case this means therefore that essence of wisdom and intelligence are present as spiritual-energetical as well as material-consciousness-based coarse-substantial forms, as organic acids.

72. This enables that essence of wisdom and intelligence can be further transplanted in a coarse-substantial manner.

73. This means that, for example, these acids can be taken from one brain and be genetically modified, in order to replant them into another brain.

74. As a result, entire races of life-forms can be brought to an equal level of essence of wisdom, knowledge, and intelligence without each individual being having to go through the different evolutionary periods.

75. In this way, even a new spirit-form (which the human being of Earth often mistakenly refers to as mentally ill and idiotic) can be turned into a highly developed knowledge and life-form.

...

77. Intelligence and essence of wisdom are thus in no way the result of genes, and they are also not transmitted and brought along by the spirit itself which inhabits the body.

78. This means therefore, that an intellectual or very wise human being can bring offspring, which the Earth-human describes as "mentally ill" and "idiotic", whereas however human beings who are weak in consciousness and intelligence can procreate offspring of horrendous development of consciousness and intelligence.

79. This is really only connected with the extent to which the respective material consciousness residing in a body is itself developed in terms of knowledge.

80. If, however, essence of wisdom and intelligence were the result of genes then a new spirit would never find a home (body), while the already existing life-form would very quickly be destroyed and extinct because it would be "spiritualised" too quickly.

81. This would be the case because only more and more highly developed life would be procreated and thus no opportunities for new spirits to live and develop would be offered any longer.

**Billy:**

But why, then, are the so-called "spirit illnesses" inheritable?

**Semjase:**

82. There are no real spirit illnesses, but only material illnesses of consciousness, and these are based on a delusion, brought about with Gewaltsamkeit, of a consciousness that is either still underdeveloped in terms of knowledge or is already educated.

83. And since **the genes are influenced by the consciousness**, they catch the confused impulses, store them and create the confused idea to become the confused life-form.

84. Life-forms disturbed in such a way, however, normalise again from generation to generation – through the unstoppable further development of the spirit and through the regeneration of the consciousness, through the evolution which is caused periodically.

85. This means thus that by the confused material consciousness, which uses the power of the spirit, vital functions of the genes are impaired, namely by the faulty control of certain factors.

86. This faulty control then in turn sets off its impulses in order to intersperse the brain acids with the same false factors and to cause a confusion, a delusion that as a result actually becomes organic.

87. The evolution of the consciousness, however, ensures that the delusion can normalise again over generations, as I have already mentioned.

88. Life-forms disturbed in such a way may be burdened differently depending on their kind, but likewise their offspring.

89. 91. But on the other hand, after many generations, after everything has normalised again, small underdeveloped factor elements may, in isolated cases, allow certain damages to break out, which lead back to them.

174. Not to that extent, no, because various other factors still play an important role.

175. The most important points with this are the external influences, such as living conditions, health, nutrition, and environment and so on.

**Billy:**

... I recently watched a programme on television about the poison glyphosate. Glyphosate is the most widely used weed killer in the world. It has been on the market for almost 40 years and is used in huge quantities. It is said that it is safe for the human being to ingest only 0.3 milligrams per kilogram of body weight and that this can be increased to 0.5 milligrams per kilogram of body weight. You know a lot about these things; what is your opinion about it?

**Ptaah:**

24. Glyphosate is dangerous and causes cancer, malformations and miscarriages, as is also the case with all pesticides and herbicides, as well as with all neurotoxins that penetrate and are

stored when sprayed on naturally growing foods, such as vegetables, berries, fruits, corn, mushrooms and grains.

25. These toxins are then absorbed by the human being through food and cause health problems.

26. In addition to cancer, malformations and miscarriages, all herbicides, pesticides and neurotoxins that enter the human body through food, pores and respiration also cause many forms of allergies, although many different diseases also appear, the causes of which are not recognised by terrestrial medical experts.

27. Glyphosate, as well as all other pesticides and all herbicides and neurotoxins are much more dangerous than chemists, manufacturers and users falsely claim.

28. On the contrary, the truth is that there is no milligram limit for these substances, because even in the smallest quantities, far below one milligram per kilogram of body weight, herbicides and pesticides, as well as neurotoxins, are very dangerous to the human being's health and therefore cause disease.

29. Nevertheless, the World Health Organization and the US Environmental Protection Agency consider that the use of these toxins in small quantities is as safe as the use of European authorities.

30. Even the seeds are soaked in neonicotinoids, which also poisons the plants growing from them, and finally, of course, the human being is also involved in the poisonous cycle of chemistry.

31. During growth, the plants absorb the poison, which consists of stable chemical compounds that only break down very weakly and are therefore transferred to the growing plants.

32. Above all, neonicotinoids are used to poison seeds, especially rape, sunflower and maize.

33. These insecticides are several times more toxic to the human organism than the notorious DDT, which has brought so much misery to countless Earth-humans.

34. Neonicotinoids are usually not applied selectively but often as a preventive measure, which makes the whole thing much worse.

35. Although selective application would have less harmful effects on the human being, the damage to health would still be very serious.

**Billy:**

Your explanation is clear and plain and says that the chemists who brew this stuff are lying, as are the manufacturers and users of these poisons.

**Ptaah:**

36. That is undeniable.

gained from your research into glyphosate and other poisons that are used in agriculture and horticulture etc. as well as in general in the form of herbicides and pesticides, which are applied on earth and poison everything.

**Ptaah:**

111. Glyphosate-containing weed killers are used by the ton, not only in agriculture but also by domestic gardeners, horticulturists and hobby gardeners.

112. Glyphosate products are manufactured by the notorious genetic engineering group Monsanto.

113. The harmful effects on nature, fauna, flora and humans are not only trivialised and played down, but also vehemently denied.

114. Anyone who can prove the harmfulness of substances containing glyphosate in relation to humans and other life-forms is silenced by Monsanto's lawyers.

115. Glyphosate, however, is very harmful and also causes cancer, whereby it is not only probably carcinogenic, but inevitably causes cancer, for which even the tiniest amounts in the nanoscale are sufficient, as well as for many other ailments and diseases, which affect humans and animals, etc.

116. The use of the herbicide in any form is not only extremely dangerous to the health of all consumers and therefore dangerous, but also to their users and consumers such as farmers, horticulturists, plantation operators, house gardeners and hobby gardeners, etc. etc.

117. Our researchers can detect glyphosate and its degradation substances at least in nanoscale regions in the air, in the rain and even in the atmosphere, as well as in higher nanodoses in groundwater and in the human body and in countless life-forms of all genera and species.

118. Glyphosate is therefore a weedkiller for the Monsanto Group, as we have already talked about, and this toxin is a very dangerous carcinogen of the worst kind, even the tiniest nanoparticles being enough to damage the organism of humans, animals and all forms of life.

119. Glyphosate-containing weed killers are not only produced by the notorious genetic engineering group Monsanto, but also elsewhere, and they are used by tons by corporations of various kinds and by authorities for weed killing.

120. The harmful, life-threatening and even life-destroying effects on nature, fauna and flora as well as on humans are deliberately played down or even denied by criminals.

121. And anyone who can prove that glyphosate is harmful in this respect will be silenced by Monsanto's lawyers, because the herbicide glyphosate is a billion-dollar business for the manufacturer of the seed and genetic engineering group Monsanto, based in St. Louis in the US state of Missouri.

122. Glyphosate-containing weed killers are so-called broad-spectrum herbicides, which are toxic to almost all plant species. These toxins have also been produced by other numerous companies since patent protection expired, so that half of the poison supply today comes from China.

123. Glyphosate is one of the most widely used herbicide active ingredients in the world, although it must be said quite clearly that, with regard to the world-famous Roundup, it is in itself much more toxic than its active ingredient glyphosate.

124. And this is because the formula also contains various other toxins, such as formaldehyde, which produces the so-called 'cocktail effect', which results in a mixture that is much more dangerous and toxic than the individual components alone.

125. As a result, when people and all forms of life come into contact with this mixture and the various toxins penetrate their bodies through the pores, mucous membranes, respiratory tract and food, the organs and blood are contaminated with all these toxins, which inevitably leads to overall organic damage.

126. This is also the case when in the beginning – which can sometimes last for years, depending on the amount of poison that has penetrated the organism, usually only at the nanoscale – no or only minor ailments and diseases develop.

127. Over time, however, these can result in serious damage, including cancer.

128. It must therefore be emphasised again and again that in the human organism and in all forms of life even the smallest amounts of toxic substances are harmful to health even in the nanoscale range and lead to serious suffering and diseases and ultimately to death.

129. It should be noted that as a rule doctors only rarely recognise the origin of the diseases, and if they still find the cause, then it is too late for the patients because they can no longer be cured of their health damage.

130. Over the years, the effect of glyphosate and the entire mixture on humans, amphibians, fish, animals, reptiles, mammals and birds has become more extensive, more dangerous, more pathogenic and more deadly, but this is denied by the manufacturer and the 'scientific experts' he bought, who allegedly investigated the effects of glyphosate and its mixtures and – of course contrary to the effective truth – could not find any danger for humans and all other life-forms.

131. As a rule, it has been said and still is said that if glyphosate or Roundup and all other toxins were used as intended, there would be no health risks for humans and other forms of life – apart from those which would have to be combated – although the opposite would be the case, which is vehemently denied on the one hand.

132. On the other hand, however, the hazardousness of the toxins cannot be determined by the relevant physicians, pathologists and other specialists, because in still small quantities in the nano range, which are already harmful to health, the toxins cannot be determined due to the lack of analytical ability or are simply concealed if their determination is already possible.

133. And this often happens through so-called 'doctors' and 'researchers' etc., who are paid horrendously for their silence or their false statements and lies.

134. So it happens that the poison production companies, like Monsanto, the producer of glyphosate, its mixture and other toxins, very quickly go on the counterattack, if not professionals paid by bribes, like private scientists and universities etc., conduct and publish studies, which expose glyphosate, its mixtures and other poisons as harmful and even deadly for humans, animals and geta animals etc., if they do not do so, the poison production companies, like e.g. Monsanto, the producer of glyphosate, its mixture and other toxins.

135. Critical researchers and scientists are simply discredited or, if necessary, gagged with threats or violently silenced by the Monsanto Group, as is practically the case with all other toxin product manufacturers.

136. Our research has shown that glyphosate, including its mixtures, is highly toxic to all soils, plants, waters, humans and all life-forms.

137. However, this is also often the case with other toxins, but especially with glyphosate an accumulation of carcinomas or tumours, growths, nodules, cancer, tumours and growths of the kidney tubules or the small renal tubules or urinary tubules in the kidneys occurs in the human body – as with various other forms of life.

138. Malignant tumours and tumours in the pancreas also develop in the supporting and connective tissue as a result of even the tiniest nanomagnets of the herbicide, as do skin cancer, lung cancer and lymph gland cancer to an increased extent.

139. Glyphosate is therefore indisputably a carcinogen, even in the smallest nano amounts.

140. But that is not all, because our research shows that even the tiniest amounts of glyphosate and all the mix toxins contained in it cause serious damage in the nanoscale nucleus of the DNA and in the chromosomes of humans, animals and all animals, etc., in the nanoscale range, which also causes autism and physical deformity, especially in offspring growing up in the womb.



141. In agriculture, plantations and horticulture, vegetables, winter rape, pulses, winter barley and summer cereals in particular are sprayed with the toxin glyphosate, which then settles in these natural foods and poisons the people and other life-forms that eat from them.

142. Today, glyphosate or other poison residues are present in practically all staple foods, such as vegetables, oats, maize, soya, wheat and sugar, etc., and thus in practically all flour products, including pasta and bakery products.

143. The fact that people and all forms of life are poisoned and made suffering and ill with the poison glyphosate – also with other toxins – is of course denied by the toxin production companies.

144. But what happens in agriculture and commercial horticulture is that before sowing the fields and gardens are sprayed with glyphosate or other toxins to free them from wild plants and weeds that are classified as weeds, which is done before harvesting specifically by Roundup to speed up the ripening of crops.

145. The bottom line is that naturally toxic and carcinogenic residues settle and accumulate in plant food and foodstuffs, which are then consumed by humans.

146. After harvesting, the herbicide is also sprayed on the stubble to prevent weed growth before soil tillage.

147. The Roundup is also marketed under the brand name Glyfos or Glypho-Unkraut-Ex and is of course also used for private use in gardens, as well as a garage space or garden path to keep house walls, walkways, stairs and squares, etc. free of weeds.

148. In principle, this should not be allowed because glyphosate should only be used by competent persons with a corresponding certificate of proof.

149. This should at least be the case, but this is usually not observed anywhere when buying small quantities, not even if you buy more than one litre bottle or even a 5 litre canister of the poison, because these are cheaper than small quantities.

150. The poison can be bought unhindered everywhere, where it is just sold, because usually – if at all – the buyers are informed only about the fact that they should not buy the means actually, because it is not permitted for the house and house garden range and private range, and because it might be acquired basically only by phytosanitary specialists.

151. As a rule, these are people who have relevant professional training and experience and a phytosanitary examination, such as gardeners, farmers or persons who have passed a corresponding examination.

152. Such tests should also make it clear that toxins, of whatever kind, should never be present in car parking lots, paved garage spaces, yards, squares and paths, etc. because, in any case, there is always a risk that they will wash into water and massively impair and poison the ecosystem, as happens when they are spread into fields, fields, gardens and meadows, etc., because the poisons seep into the groundwater and, sooner or later, reach the plant spray water and drinking water in this way.

153. Unfortunately, however, no purchaser of glyphosate or other poisons is required to indicate exactly where they will use the toxins.

154. So they buy the various poisons or even the most dangerous glyphosate and spray with it very generously everything that comes before the spray nozzle to them.

155. If rain is then added, the glyphosate or other poison is flushed into the next drain or ditch, where the highly toxic substances drain into the water and poison it.

156. Depending on the amount of glyphosate or other poisons in the water, almost everything that grows and lives and comes into contact with the poisoned water or is contaminated by it through bathing or drinking is poisoned and destroyed, regardless of whether it is algae, amphibians, pure bottom plants, fish, beetles, dragonfly larvae, newts, reptiles, birds, aquatic plants or vertebrates, or even humans.

157. Although humans are neither amphibians nor other forms of life in the wild, what they are able to kill with toxins is harmful to their health and does not leave them untouched, even to the

point of death, and even if the glyphosate or other toxins, even if only in the nanoscale, slowly but surely develop into incurable cancer over the years.

158. Earth-humans must protect themselves and their environment from weed killers, with the Roundup and its continuation products in the first place, but also all other toxins of all kinds that must not be forgotten.

159. In principle, care must be taken to ensure that regional foodstuffs from an effectively high-quality organic cultivation are used, because these are largely protected from herbicides such as Roundup, as well as from pesticide contamination.

160. However, this does not mean that organic products can be absolutely protected from toxins, but kept, planted, bred, grown and harvested in a state that contains an absolute minimum of toxins.

161. These move in minimal nano-areas, which of course does not prevent suffering and diseases, but can minimise them.

162. It should be borne in mind that minute amounts of toxins of all kinds are also contained in the air, in rainwater and groundwater and thus in splash water for the organic products, even if these cannot be detected by Earthly analysis equipment, which is still very inadequate, as a result of the minute quantities of nanomaterials of herbicides and pesticides – at least not yet today.

163. It must also be said that many wild plants that have fallen into disrepute as weeds – provided they are edible for humans – have a much higher nutritional value than any cultivated vegetable.

**Billy:**

In 1971, Monsanto patented glyphosate as a herbicide, and since then the Roundup alone has generated annual sales of \$2 billion. I have read about this, as well as that in Switzerland alone 300 tons of glyphosate are sold each year, poisoning fields, fields, gardens and private gardens, waters as well as roads, railway embankments, paths and meadows, whereas in Germany, according to surveys by the University of Göttingen, glyphosate is currently sprayed on 39 percent of the arable land. However, the poison companies deny any connection with their poisons and the health damages of many people, but according to a new study this is no longer so easy, because it – carried out by the International Agency for Research on Cancer (IARC), an institution of the WHO – proves the opposite. The study was published in March 2015 in the journal Lancet Oncology, highlighting five organophosphates used as herbicides or pesticides that are highly carcinogenic, including the herbicide glyphosate, which is classified in the 2A group, which includes substances that definitely cause cancer in humans, animals, getaways and all life-forms. This study is a metastudy conducted since 2001 and relates to various studies in the USA, Canada and Sweden. Cancer experts from 11 countries unanimously concluded that Roundup causes cancer in animals. What happens to people in this regard was probably also taken into consideration, but what this has resulted in is clear.

**Ptaah:**

164. I am aware of that, but the companies producing toxins are probably not deterred by it.

**Billy:**

You're probably right, because they have tremendous power that reaches as far as the governments, where various bribes are addicted, who hold out their hollow hands.

**Ptaah:**

165. That is undeniably so, therefore I have nothing about it ...

106. Against all denials of the manufacturer Monsanto, its 'expert judges' and the governments and health authorities, which call the herbicide or total herbicide glyphosate as harmless and not harmful to human health, exactly the opposite is the case.

107. As a result of your interest, we have been able to prove in large-scale research that glyphosate is life-threatening to humans and all fauna organisms even in the smallest amounts.

108. In humans alone, cancer and many other diseases and ailments are caused by glyphosate, but all mammals and other life-forms also suffer health damage in many ways, even from minimal amounts of glyphosate, which is extremely toxic.

109. The diversity of plant species is also impaired by this and over time is even brought to extinction.

110. In addition, even the slightest amount of glyphosate is deposited in the plants, which serve as food for humans and mammals, etc., when treated with the herbicide.

111. Therefore, the smallest amounts of toxic glyphosate residues can be found in foods naturally produced for human consumption and also in industrially produced foods, as well as in forage plants and waters that serve as food and drinking water for wildlife and small organisms.

112. Enrichments as toxic residues are also found in all kinds of feedingstuffs, in particular in products used in agriculture for feeding horses, cattle, pigs and poultry.

113. Toxic glyphosate residues, however, are also contained in food for life-forms kept by terrestrial humans as household members, such as dogs, cats, birds, mice, rats and hamsters, etc.

114. Due to the low glyphosate residues in the natural food plants, these are thus transported in various ways into the food of humans and all living beings, and consequently the food meat of slaughtered animals is also contaminated, which is consumed by humans.

115. This in turn leads to malformations in newborns, miscarriages, kidney damage and various types of cancer.

116. According to our research, glyphosate damages the environment and health of humans, fauna and flora in a way that is not even excessively characteristic of all other known herbicides.

117. And when it rains, the glyphosate applied is flushed by the plants and paths etc. sprayed with it into the next sewage ditches, into the sewage systems, into brooks, ponds and rivers, but it also seeps away underground and poisons the groundwater, because glyphosate is highly toxic to water.

118. Depending on the dose, glyphosate in water destroys almost everything that lives and grows in it – whether fish, insects, newts, frogs, dragonfly larvae, algae or aquatic plants, as well as many terrestrial organisms, die from it and at least become ill and sick when they drink the water contaminated with glyphosate.

119. And what kills the fauna and flora also leaves its mark on humans, making them sick and suffering, following which they suffer from cancer, allergies, epidemics and diseases due to glyphosate residues and die miserably.

120. And in this way it goes on for years, in which glyphosate gradually creates cancer, diseases, sufferings and epidemics.

121. This also includes autism, which usually develops in the mother's womb in food contaminated by glyphosate and is then absorbed by the newborn through the mother's milk, which is also contaminated.

122. But glyphosate does not only affect farmers, whom I have mentioned in relation to agriculture, because it also affects all gardeners and hobby gardeners, railway workers and chicory workers, etc., who deal directly with glyphosate and take in glyphosate residues via skin pores and possibly also via the mouth, which also settle in all basic foodstuffs.

123. Glyphosate is thus found in barley, oats, rice, rye and wheat and via these also in many flour products, such as pasta and bakery products, but also in cereal flakes of all kinds, as well as in maize, soya and sugar, etc.

124. But vegetables and berries are also affected, as is drinking water, because the toxic substances, as already mentioned, seep into the groundwater and sooner or later this is used by humans for food preparation and also drunk by all imaginable creatures.

125. And if glyphosate is ingested by humans through food and drink, even in small amounts, it will sooner or later have a toxic effect, even on mothers with regard to mother's milk, which in one way or another damages the health of foetuses in the womb, as well as causing malformations and miscarriages.

126. Also respiratory problems and skin diseases are caused by glyphosate, as well as an increasing loss of biological diversity, such as the rapid death of bees.

127. Glyphosate also triggers chronic botulism in cattle, a poisoning disease that can affect both humans and all mammals.

128. Even in small amounts, glyphosate and other glyphosate-containing substances damage human embryonic and placenta cells as well as the DNA of humans, amphibians, animals, animals, reptiles, birds, fish, other aquatic organisms and all kinds of other life-forms.

129. In the human body, glyphosate can lead to complete cell death within just 24 hours.

130. Glyphosate also paves the way for Alzheimer's and diabetes and, as already mentioned, for cancer and all sorts of diseases and body diseases, as well as for depression, heart attacks and infertility in both sexes.

131. Glyphosate also has very high negative effects on soil fertility and overall soil organisms.

132. Certain pathogenic parasitic moulds are also promoted, such as *Fusarium* fungi that kill their host.

133. Micro-nutrients can no longer be absorbed by micro-organisms and fungi and plants can no longer defend themselves against disease, which means that Earthworms, which are indispensable for the aeration of soils, die out or avoid soils contaminated with glyphosate.

134. Glyphosate appears in the urine of humans, animals and other living organisms of various species, even if they have not come into direct contact with glyphosate when spraying plants, soil, water, etc.

135. There is a classical or acute botulism and a chronic or visceral botulism, whereby both forms are caused by toxins of the bacterium '*Clostridium botulinum*', whereby especially the nerve toxin 'BoNT' or neurotoxin is of enormous importance and the strongest toxin at all.

136. In purely theoretical terms, a mere 40 grams would suffice to destroy the entire Earthly human race.

137. If the symptoms of botulism are considered in diseased cattle, then emaciation or a life-threatening emaciation, as well as a drop in performance, such as in consumption or tuberculosis and cancer, are noticeable.

138. Further symptoms are a duck run, also known as watschell run, as well as a pulled up belly, staggering and limited reflexes, whereby also a disturbed drinking behaviour and continuous salivation are typical, as well as abomasal dislocations and non-healing skin wounds

as well as rumen paralysis or paralysis of the largest of the three preomachs, which serves as a large fermentation chamber.

139. Botulism bacteria primarily multiply in meat and plants when they fall into decay.

140. If cattle ingest such bacteria through food that is interspersed with the neurotoxin BoNT, a case of classical botulism arises.

141. Chronic botulism is initially caused solely by the spores of the botulism bacteria when they are ingested with food and only begin to act and germinate in the intestinal tract.

142. Cattle suffering from chronic botulism due to chronic glyphosate poisoning become permanent excretors of spores of botulism bacteria.

143. This also creates an increased and permanent risk of infection for uninfected animals, which can also infect farmers, other people and other living creatures.

144. In humans, an infection can lead to eyelid heaviness, muscle weakness, difficulty swallowing, such as a dip in the throat, and a frequent urge to urinate with a persistent feeling of residual urine.

145. Glyphosate kills all health-promoting bacteria in the stomach and intestines of humans, cattle and all forms of life, thus causing severe damage to the intestinal flora, which means that bacteria of all kinds, especially the botulism bacterium, can no longer be sufficiently repelled.

**Billy:**

However, the policy does not do anything about it and consequently the prospects for an effective hazard classification with regard to glyphosate and thus a corresponding ban on the dangerous active substance are not considered at all. It is disillusioning that Monsanto and the majority of health researchers, politicians and governments have known for about 20 years that glyphosate contains life-threatening substances for all living beings. However, this is irresponsibly trivialized or fundamentally denied, and many people continue to die of cancer and other diseases and ailments, as well as many birth defects caused by glyphosate. On the whole, there has been little or no political action so far to ban glyphosate as a matter of principle, so that it can only be assumed whether it will ever be banned at all. The fact is that many of the politicians and Commissioners are high-ranking employees who have to decide on such things – and they stand for genetically modified feed and food closely linked to the agro-industry – who are paid horrendously for their support for the production and sale of glyphosate and so on. If one looks at these politicians, commissioners and high-ranking employees who vote for glyphosate and other toxic pesticides and their residues, it is clear that some of these proponents are or have been closely associated with, among others, toxin producers, such as the large corporations BASF, Bayer, Monsanto and Syngenta, etc. And these are corporations that are massively opposed to a ban on certain pesticides and that all have products containing glyphosate in their product ranges. If one considers that Monsanto alone with its glyphosate-containing product 'Roundup' has a turnover of 2 billion US dollars, then it should be absolutely clear that all other agrochemical companies and their representatives are also earning large fortunes and are therefore already trying to prevent a ban on this active ingredient. Your findings alone make it absolutely clear that glyphosate, the plant destroyer, is highly hostile to life and even deadly to humans, fauna and flora and thus to the whole world. However, the fact that so far, from a political point of view, not enough has been done to ban glyphosate in its production, sale and use can effectively be seen as political failure. It is simply incomprehensible that, despite all negative signs, glyphosate-containing products may continue to be produced, sold and distributed on a massive scale, although an immediate halt to production, sale and use must be the only correct measure that can be considered.

146. The fact is that our research clearly proves that glyphosate causes health and other damage and even death to humans, fauna and flora.

**Billy:**

The interests of agriculture and large-scale horticulture should no longer be given economic precedence, but immediate action should be taken wherever glyphosate has long caused serious damage to fauna and flora and is still causing increasing damage, especially to human health. An immediate halt to the production, sale and use of glyphosate is of the utmost urgency, as treated food and feed causes death, extinction of fauna and flora and spoilage. Last but not least, the entire political system must also be called into question, which does not assume its responsibility and allows Monsanto and the poison economy as a whole to exert pressure on farmers and nurseries to achieve ever higher yields, as do Monsanto and other poison corporations, ever more horrendous profits – regardless of people, nature, its fauna and flora, water and the entire environment.

63. This is the type of development of the still primitive science which, with a few exceptions, always has very little success.

64. For example, our scientists also work with transplantation of eyes and other organs, however, these are then transferred to them from the cultivated, living material of the particular life-forms.

65. Therein they have achieved complete successes.

66. However, eyes, limbs and organs of all kinds are cultivated and transplanted by our scientists because the natural human eye, limbs and organs and the whole cell tissue, etc. cannot be replaced by any technology.

67. So body organs as well as limbs are not removed from the living or dead in order to be transferred to the living.

68. Such transplantations involve very great dangers in various forms, of which I would like to mention just two important ones:

69. One risk factor is the complete destruction of the immune system of the body to which a limb or organ is transplanted by a foreign body.

70. This means that the body on which the transplantation is performed must be rendered completely defenceless by anaesthetics, toxins, etc., i.e. its immune system must be completely destroyed so that it does not repel the transplanted organ or body part.

71. Thus the body becomes very dangerously susceptible to any external influences, so a very small dust particle can already be enough to endanger the body, so that the life form dies.

72. The second factor to be mentioned is that of the foreign fluidal-energies that are inherent in the transplanted part of the foreign body.

73. This transferred fluidal-energy works with complete certainty against the inherent energies in the body into which they are forceably transplanted.

74. This creates many dangers as well as bodily and consciousness-degenerating factors.

...

78. ... that is why terrestrial medical-surgical science should try not to perform such transplants.

79. The good form is the production of artificial and useful organs of replacement, etc., grown from the patient's own cell tissues.

**Billy:**

51. You know that we have been doing a lot of transplants here on Earth for a few years now.

52. With each of these operations, however, there is always the danger that the patient will only survive for a short time.

53. This is because the foreign transplants are repelled by the body, which is why the body is treated with medication, etc. to such an extent that all antibodies and defence organs in the human body are rendered inoperative, which of course has the consequence that the body becomes highly susceptible to infections, etc., which leads to the death of the patient a short time after the transplantation, at least at present.

54. I now have the question whether it is actually not possible to carry out a transplantation with good or even the best success without the defensive substances and organs in the human body being rendered inoperative.

55. If this is possible, can or may you then tell me what science has to do to be successful?

73. If a transplant is to be successful, then relatively little is required, namely a simple serum, a gene combination, which I am not allowed to describe in more detail.

74. Various earthly scientists researching this field have already found this serum and used it in animal experiments for tests.

75. They name the product they produce **antigen** serum, which is made from very specific substances from those animals which may later supply the transplants.

76. However, this serum must already be delivered to the foetus in the womb, after which the foetus immunises itself by developing the relevant serum substances of the animals in cooperation with the foetus' own substances in such a form that the substances build up in commonality and become transplant-friendly.

77. The foreign substances that build up program certain control centres of very specific cells, so these become known through the antigen serum supplied to them at an early stage, whereby they later recognise transplants of those animals as their own property from those substances contained in the serum.

78. The exact same process takes place when the serum is produced from certain substances of another human life-form.

...

80. Your science should take this step now, because it is evolutionary, even if you will later deviate from it again, because better and further ways will open up and because the realisation will arise that the fluidal powers inherent in transplants are harmful in the long run and influence the carriers of transplants positively or negatively depending on their value and their power.

81. With the human life-form, no matter which race it belongs to, only the human species is important; it is the highest physical form of life with very specific, special characteristics that are not found in animal or floral life.

82. As an autonomous small world, everything is regarded as an intruder and foreign body to the human life-form in the case of foreign transplants, etc.

## **Water (Drinking)**

If I now address the trace substances that are detectable in drinking water, then it is to be said that these are completely different in their type and quantity, because depending on the location, environment and human local activity, such as a market garden, agricultural enterprise, factory, settlement zone or industrial zone and time, the trace substances occur in higher or lower concentrations. These substances are, for example, drug residues, pesticides or nitrates,

microplastics, germs or metals, etc. Depending on their types and concentrations, these can be hazardous to health, whereas really clean water is purified in such a manner that its concentration of trace substances is usually so low in terms of health hazards that there is no risk to health, even if the delicious water is drunk for a lifetime and used for food preparation. This is indeed usually set by law, so for tap water the limit value for trace substances hazardous to health is far below where recognisable damage to health occurs. But to be honest: even if all this is permanently controlled by law, it is honest and important to say that even the smallest as well as legally permitted amounts of trace substances are harmful to health if they occur in drinking water. So tap water is usually always contaminated with trace substances, even if the quality is permanently checked and a minimum amount of trace substances is legally defined and allowed.

As far as the very valuable minerals that the human body needs and that are contained in drinking water and tap water are concerned, these contain more or less of the important minerals depending on their origin, which can vary depending on the source, lake water or groundwater. If, in comparison, mineral water resp. the so-called brand waters are examined, then tap water actually does very well, because only about half of the commercially available brand waters contain significantly more minerals than tap water. This is also explained by the fact that the human body can only absorb a certain amount of minerals, which are also usually already contained in the solid foods that human beings eat every day. This means that, as a rule, a high mineral content in water is not particularly necessary, but quite normal. Nor is a high and special value necessary under certain circumstances, because water absorbs many valuable minerals in the course of its natural cycle, which human beings and every other life-form need for a healthy life. It is also worth explaining that trace substances in the range of micrograms (mg) and nanograms (ng) are present in water, but these are small units of measurement in minimal form that can be classified as unimaginably small. If, for example, human beings drink a medicine with a concentration of 100 ng of active ingredient, it would take them 700 years to absorb 100 ng if they drank 2 litres of water a day. That is actually what I know and have to say.
